Muhammad Ali Mazhar, J: On last date of hearing Mr. Ali Asghar Mehar, Focal Person, Home Department submitted a copy of notification dated 20.11.2017 to show that the name of the petitioner was removed from IVth Schedule of ATA, 1997 with immediate effect but counsel for the petitioner raised the contention that despite this notification, CNIC of the petitioner is blocked and he cannot operate his bank account and neither the name of the petitioner has been removed from the website of the Home Department nor from the website of National Counter Terrorism Authority Pakistan. On this, Focal Person undertook that they will immediately send

the notification and also make request to remove the name of the petitioner in view of the notification dated 20.11.2017. Today Section Officer Home Department has submitted the statement on behalf of Home Department and also attached a copy of notification dated 30.04.2021 which is reproduced as under:

NOTIFICATION

NO.SO(JUDL-II)HD/8-04/202018: In continuation and partial modification of this department notification of even number dated 20.11.2017, the Government of Sindh, Home Department Sindh is pleased to remove the name of Fayyaz (CNIC 42401-2407037-5) r/o Zia Colony Sector-4 Mominabad, Orangi Town, Karachi Sindh from the 4th Schedule of ATA-1997, with immediate effect and the name of the said person is hereby deleted from the list of 4th Schedule of Anti Terrorism Act-1997.
