Muhammad Ali Mazhar,J: Syed Hakim Masood, FID, DRAP has submitted a copy of letter dated 30.04.2021 issued by Assistant Director (Costing & Pricing), Drugs Regulatory Authority of Pakistan to show that MRP of the petitioner's vaccination has been approved. The letter is reproduced as under:-

2. It is clarified that MRP @ Rs.340 / 1's has been fixed in 10th PAC on 19-03-2010 in respect of following drug composition:-

*"Salmonella typhi- Ty 2 Injection
Each 0.5ml contains:-
Vi Capsule Poly Saccharide Powder
(from Strain of Salmonella Typhi- Ty 2)
... ..0.025mg"*

3. Division of Biological Drugs may communicate the MRP to the company.

The petition is disposed of accordingly alongwith pending application. Copy of this order may be transmitted to the Secretary, Ministry of National Health Services Regulations and Coordination as well as Secretary Cabinet, Islamabad and learned Assistant Attorney General for Pakistan.
