**ORDER**

 **MUHAMMAD SHAFI SIDDIQUI, J.** - In these petitions, petitioners essentially sought for directions against respondents to issue necessary permission to

them to run the hotel during the holy month of *Ramzan*. The question involved in these petitions came for consideration before different benches of this Court in a number of petitions which were accordingly disposed of vide detailed orders, one of them, being in C.P. No.D-709 of 2019 and others being C.P. No.D-1007 of 2018. The ratio of the judgments was that this Court although do not enjoy the jurisdiction to pass an appropriate orders as far as the merits of the application is concerned; however, it is the jurisdiction vested with the forums as described in the judgments referred above. We, therefore, in view of the pronouncements referred above disposed of these petitions that the applications of the petitioners as claimed to have been pending before Deputy Commissioner concerned to be decided on the strength of the ratio decided in the above referred judgments at the earliest, after hearing the petitioners. Petitions along-with pending applications stand disposed of.
