 - (i) Mst. Sakina wd/o Muhammad Khan applicant No.1(i) 25 paisa
 - (ii) Haji Khan applicant No.1(ii)/ Respondent No.1.

- 3. The record of right be mutated accordingly by Respondent No.3.
- 4. That the costs shall be borne by the parties and instant Revision application may be disposed of accordingly.

Both the Applicant No.(i) viz. Mst. Sakina wd/o Muhammad Khan having CNIC No.44204-8444139-6 and the Applicant No.(ii) viz. Dr. Haji Khan son of Late



Haji Muhammad Laiq [already Respondent No.1], having CNIC No.42301-2940171-5, are present in Court not only admit the contents of the compromise Application under Order-23 Rule-3 C.P.C [CMA No.1119 of 2018], but also admit their signatures thereon. The learned counsel for the parties beside verifying the signatures of the applicants admit the contents of the compromise Application under Order-23 Rule-3 C.P.C [CMA No.1119 of 2018], as being correct and lawful. Besides, both the learned counsel for the parties have also signed the compromise Application under Order 23 Rule-3 CPC bearing CMA No.1119 of 2018.
