On the last date of hearing, a Statement had been filed on behalf of the Provincial Election Commissioner, Sindh reflecting that a meeting had been scheduled for 09.11.2022, at Islamabad, for fixing the date of the repeatedly postponed Local Government Elections-2022 in Karachi Division. Today, we have been informed that such meeting could not take place as a Public Holiday was declared on that date and the meeting has been rescheduled. Furthermore, the Senior Law Officer of the Provincial Election Commissioner, Sindh, in attendance, submits that the main cause due to which the elections in Karachi and Hyderabad Divisions have not been held to date is that the requisite security deployment is not being made available by the Government of Sindh on the pretext that the relevant personnel are engaged in flood relief operations. On that

note, we had called for a Report from the Inspector General of Police,

Sindh as well as DG. Pakistan Rangers, Sindh, on the previous date,

however, such report has not been forthcoming as yet.

Under such circumstances, the learned Advocate General, Sindh is

directed to obtain the complete information as to the total strength of

Police Personnel and Rangers Personnel in the Province alongwith their

current deployment(s), as well as the number of such Personnel as can

be assigned for duty in respect of the aforementioned Local Government

Elections. To come up on 14.11.2022, at 12.00 Noon, when Provincial

Election Commissioner, Inspector General of Police, Sindh and the Chief

Secretary Sindh should be present in person.
