Petitioner claims that he had donated the plot for construction of School and in lieu thereof one person is to be appointed as Chowkidar or Daftari. Let the petitioner first establish from the revenue record before the concerned authorities that the plot has been donated for School and thereafter it shall also be verified whether the School has been constructed on the plot belonging to the petitioner. If there are any co-owners of the plot in question than all the co-owners shall give no objection and transfer the plot in favour of the Education Department. In case it is ascertained that plot was utilized for School without any compensation to the owner than after transfer of the ownership of the plot in question in favour of the Education Department whenever any vacancy in the said School occurs, the job shall be granted to the owner or his nominee only after all the above mandated requirements are fulfilled.

With these directions, this petition is disposed of.
