The Respondent No.2 files statement, same is taken on record.

At the very out-set, learned State Counsel submits that he has no objection, if the instant petition is allowed in terms of order dated 25.10.2011 passed in Constitution Petition No.D- 2162 of 2010.

In view above, instant petition is disposed with direction to respondent No.1 to process and move the case of petitioner and decide it within a period of one month, provided that petitioner shall fulfill the following terms.

- (i) Copy of Agreement Bond signed by the applicant/plot donor and EDO (E) Naushahro Feroze regarding construction of School building.
- (ii) Copy of Form VII-B duly signed by Mukhtiarkar (Land Revenue) concerned, showing the ownership of plot/land of the applicant.
- (iii) N.O.C of other share-holders of land/plot and other heirs of property.
- (iv) Qualification certificates, CNIC, Domicile and PRC of the applicant, Certificate from relevant officer that land donated

for construction of school building stand transferred in the name of Education & Literacy Department, Government of Sindh.

- (v) The petitioner shall ensure that other share-holders of S.Nos.263 & 264 of Deh Garho. Taluka Moro. appear in person before the Executive District Officer (Education). Naushahro Feroze and give their no objection in favour of petitioner or his nominee.

The petition stands disposed of in the above terms.
