The petitioners, through instant Constitutional Petition, have challenged the partition order dated 22.12.2020 passed by the Assistant Commissioner (Revenue), Faiz Ganj/respondent No.4 in Sessions Case No.105 of 2008, arisen out of Crime No.45 of 2008 registered at Police Station Faiz Ganj, District Khairpur under Sections 302, 114, 147, 148, 149, 324, 337-F(iii), 337-F(v), 337-H(2), P.P.C., wherein the land of respondent No.7, namely, Kaleem Hussain was attached by the said learned trial Court, which was, as per the claim of the petitioners, joint holding of the petitioners and respondents No.7 & 8, situated in various survey numbers of Deh Khair Muhammad Mojai; besides, a piece of land admeasuring 01 acre out of Survey No.119 and 196, situated in Deh Kot Laloo, Taluka Faiz Ganj, which allegedly purchased by the petitioner No.1 from respondent No.7 under registered sale deed on 02.08.2010 during latter's absconsion in the aforementioned sessions case.
