## **ORDER**

**Agha Faisal**, **J**. The plaintiff, *admittedly* a civil servant serving in the Federal Board of Revenue, has essentially challenged his transfer orders vide this suit.

On the last date of hearing, the plaintiff's learned counsel was confronted the objection of maintainability *inter alia* as to how a matter pertaining to terms and conditions of service of civil servants may be agitated in a civil suit; in view of the bar contained in Article 212 of the Constitution as appreciated by the Supreme Court in *Ali Azhar Baloch*<sup>1</sup>.

The learned counsel sought time to obtain instructions and today has intimated the court that the plaintiff is not convinced that his matter falls within the jurisdiction of the service tribunal.

This court has determined a similar matter, *Nasser Janjua*<sup>2</sup>, and in *mutatis mutandis* application of the reasoning and rationale assigned therein it is observed that the grievance of the plaintiff could not be adjudicated in a civil suit; in view of the bar contained in Article 212 of the Constitution, as interpreted by the Supreme Court from time to time; including in *Ali Azhar Baloch*<sup>3</sup>. Therefore, the plaint is hereby rejected per Order VII rule 11(d) CPC<sup>4</sup>.
