It appears that vide orders dated 14.12.2016 and 22.12.2016, the Secretary Health, Government of Sindh was directed to constitute a board to examine Mst.Wazeeran at Panah Shelter Home, Karachi in order to provide her proper treatment. Yet report is not received. We once again direct the Secretary Health, Government of Sindh to constitute a team of the Doctors of the relevant field, especially psychiatrist to examine Mst. Wazeeran and provide her proper

treatment. Thereafter, she shall be shifted by the Incharge Panah Shelter Home, Karachi to Darul Aman, Hyderabad. Proper treatment shall be provided to her at Darul Aman, Hyderabad also.
