Appellant Aftab S/o Muhammad Yasin was tried by learned 1st Additional Sessions Judge/Special Judge (CNS), Hyderabad in Special Case No.07 of 2010 arising out of Crime No.11 of 2010 for offence under Section 9(c) Control of Narcotic Substances Act, 1997. By judgment dated 12.04.2012, the appellant was convicted under Section (c) Control of Narcotic Substances Act, 1997 and sentenced to imprisonment for 14 years and to pay a fine of Rs.50,000/-, in default whereof to suffer R.I for 06 months more. However, benefit of Section 382(B) Cr.P.C was extended to the appellant.

Appellant had filed Criminal Jail Appeal No.D-127 of 2012 through the Superintendent Central Prison, Hyderabad.

Mr. Ghulam Asghar Mirbahar, Advocate filed power on behalf of appellant Aftab in Criminal Appeal No.D-144 of 2012. This Court vide judgment dated 17.03.2016 dismissed the said appeal on merits. However, modified the sentence awarded to the appellant to one already undergone by him. Inadvertently, Criminal Jail Appeal No.D-127 of 2012 was not fixed before this Court on 17.03.2016, which is still pending as conviction of the appellant in Criminal Jail Appeal No.D-127 of 2012 has already been maintained and the sentence has been modified and the appellant has been released from the prison as per letter dated 25.03.2016 issued by the Superintendent Central Prison, Hyderabad, therefore, Criminal Jail Appeal No.D-127 of 2012, which is still pending, has become infructuous and the same is accordingly disposed of.
