- 3. Through this application, the applicants/accused Naveed Ali, Roshan Ali, Babar Ali and Ali Hyder seek protective bail in Crime No.11 of 2017 registered at P.S Airport, Shaheed Benazirabad, under Sections 324, 506/2, 353, 147, 148 & 34 PPC.

It is, *inter alia*, contended by the learned Counsel for the applicants/accused that applicants/accused are innocent and they have been falsely implicated by the complainant with ulterior motives; that applicant Roshan Ali is an old person and a Pesh Imam, while other applicants/accused are government servants and cannot think to indulge in such activities; that the applicants/accused tried to surrender themselves before the learned trial Court but due to apprehension they could not appear before the learned trial Court. He lastly submits that applicants/accused may be granted protective bail, so that they can appear before the concerned trial Court for appropriate remedy.

Without touching merits of the case, all the applicants/accused are granted protective bail for a period of 05 days from today to appear before the concerned trial Court, subject to their furnishing solvent surety in the sum of Rs.30,000/- (Rupees Thirty Thousand) each and P.R. Bond in the like amount to the satisfaction of Additional Registrar of this Court. This order shall cease to have its effect on expiry of five days from today or whenever the applicants/accused surrender themselves before the learned trial Court, whichever is earlier.

This order shall cease to have its effect on expiry of four days from today or whenever the applicants/accused surrender themselves before the trial Court, whichever is earlier.
