- 2. A perusal of the report at Table-A, it reflects that w.e.f 2009-2010 to 2023-2024, out of total schemes, 5608schemes have been completed. According to the Chart, 4593 schemes do not require approval of SNEs, however, in 863 schemes SNEs have been approved and in 152 schemes SNEs are required to be approved, whereas, Chart at Table-B shows that out of total schemes, 2778 schemes have been completed, 1763 schemes do not require approval of SNEs, whereas in 863 schemes SNEs have been approved and there remain 152 schemes in which SNEs are to be approved and Chart at Table-C reflects that total schemes completed are 2830 and in all such schemes SNEs are not required to be approved.
- 3. At this juncture, the Chairperson of the Committee requests that at the first instance Committee may be tasked to work out the SNEs on Provincial level and in second phase they will carry out the schemes initiated from Districtwise budget. Order accordingly. However, it appears that according to Chart at

Table-A in total 152 schemes SNEs have not yet been approved, therefore, it is ordered that SNEs of those 152 schemes shall be approved within a month.

- 4. We have also noted that the chart in Table-A shows that out of 5608 schemes, 4593 schemes do not require approval of SNEs. In Table-B, it appears that 2778 schemes have been completed, out of which 1763 do not require SNEs, and the chart in Table-C depicts that a total of 2830 schemes have been completed, all of which do not require approval of SNEs. It is alarming that such a large number of schemes have been completed which, according to the chart submitted by the Committee, do not require approval of SNEs, meaning thereby that the main focus of the Government is only to initiate projects which are not institution-based. Therefore, the Committee shall examine this aspect and submit a detailed report with descriptions of these schemes and the causes thereof, as well as determine whether these schemes were created or launched to siphon funds from the public exchequer.
- 5. The Committee's report reflects that some of the Departments have not provided the required data. Accordingly, the concerned Secretaries are directed to provide data to the Committee before the next date of hearing. The Committee in its report has also highlighted the causes and technical hurdles of the delays in SNEs approval as well as the recommendations in this behalf. However, the concerned Secretaries of the Departments shall submit their detailed reports to this effect before the next date of hearing.
- 6. Pursuant to para-3 of order dated 28.09.2024, the Secretary P&D Department submitted report, inter alia, underlining the reasons and circumstances that led to the delay in the approval of SNE for the projects/schemes, some of them, being relevant, are as under:

- "a. SNEs after approval of Budget for the Financial Year is not entertained by the Finance Department during the FY.
- b. Lack of capacity of the Executing Department for timely submission of PC-IVs.
- c. Non-submission of timely PC-IV and partially completed PC-IVs by Administrative Departments.
- d. Delay in compliance of observations raised by P&D Department on submitted PC-IVs.
- d. Umbrella schemes where some units are completed and some units are under construction therefore, the completed units suffer and awaited SNE till completion of umbrella scheme."
- 7. In the aforesaid report, time was also sought to collect the information of public schemes of remaining departments. Accordingly, the compressive report, as directed vide aforesaid order, shall be submitted before the next date of hearing.
- 8. Accordingly, the Secretaries of the concerned Departments shown in the aforementioned Charts, whose SNEs have not been approved, shall submit the detailed reasons of the delay caused in approval of the SNEs, which shall be submitted before the next date of hearing.
- 9. In pursuance of order dated 28th September 2024, the Special Secretary, Health Department has filed statement Annexure "A" thereof reflects that during the last 15 years 184 schemes were initiated, out of which 177 have been completed; SNEs relating to 77 scheme were sanctioned, whereas for 73 scheme approval of SNEs was not required; 20 scheme were operationalized by SICHN, SICVD, SIOVS, SIUT, KMC & through existing SNE by the concerned hospitals; 07 schemes require SNE/PC-IV and 07 schemes have been dropped. Accordingly, SNEs/PC-IV which have not yet been approved shall immediately

be approved and the Committee shall fix the responsibility of delay in approval

of SNEs in time.

10. Pursuant to referred order, Secretary of the Works and Services

Department was directed to submit comprehensive details of all public projects,

including High and Higher Secondary Schools, Livestock buildings, and other

schemes that have been completed but for which the SNE has not yet been

approved. The Secretary was also directed to provide an explanation for the

delays in SNE approval for these projects. In compliance thereof, report filed by

the Secretary Works and Services Department, inter alia, reflects that 2390

schemes of road sector and 08 schemes of building sector during last 15 years

have been completed wherein no SNE was required; however, list of those

schemes is not attached with the compliance report. Accordingly, Secretary

Works & Services Department is directed to place on record the list of schemes

on the next date of hearing.
