Petitioner Counsel for five of the six petitioners, 1 submits that he has impugned the Respondent/SSGC Notices of various dates,2 issued to the Petitioner entity for allegedly unlawful load enhancement/increase of its gas load.³ The Respondent/SSGC claimed that the Petitioner entity had been sanctioned a monthly load which demonstrated their capacity of gas utility,4 when subsequently Respondent/SSGC found through its survey teams that Petitioner entity's gas consumption by way of connected load was more than the sanctioned load, inspite of a general notice which was apparently issued to industrial consumers sometime in October 2020 who were drawing more than their approved gas load to regularize their connections before 30.11.2020, failing which any quantity taken in excess of their approved gas load shall be charged at the full LNG price without exception or else they shall be curtailed to their approved gas load, but, according to Respondent/SSGC Counsel, the Petitioner allegedly took no

positive action.⁵ Petitioner Counsel vehemently opposed Respondent/SSGC's submissions as well as denied the allegation of gas theft and tampering with the gas meter.

To resolve the matter amicably, the parties counsel, have agreed that the Petitioner entity shall immediately regularize its connected Gas Load through a new GSA of RLING with the Gas Load to be determined in the first instance, based on the last joint survey carried out by Respondent/SSGC, notwithstanding, that Respondent/SSGC reserves the right in its sole discretion to conduct a Joint Load Survey at the Petitioner entity's factory premises to assess its current gas load, afresh, and subject to the outcome of such fresh Joint Survey, as the case may be, to demand additional Gas Security Deposit ("GSD") as well as to charge the rate of RLNG as prescribed for the subject period. The recovery of unpaid amount, if any, found during this period will be treated as a normal load extension and will not be subject to late payment surcharge or any other penalty. The Petitioner will submit a fresh Undertaking as per practice to Respondent/SSGC and covenant to neither carry on any extension/alteration of the gas line nor connect any additional appliances nor increase the sanctioned load on its own for any reason whatsoever without obtaining prior approval of the Respondent/SSGC for such increase in load in writing. This entire exercise agreed upon today shall be reduced into writing in the form of an Agreement. The Respondent/SSGC allegation of theft and gas meter tempering stands withdrawn as conceeded by Mr. Kashif Hanif, Advocate.

Accordingly, based on the parties' above understanding as recorded herein, the above Petitions are disposed of in the above terms with the entire exercise to be completed in six (6) months.
