The grievance of the petitioner is that after qualifying the test conducted by the IBA Sukkur and on the recommendations of District Selection Committee, she was appointed as PST on U.C-wise basis and posted at her own U.C Syedpur at GGPS Syedpur Taluka Ubauro, District Ghotki and now she has been transferred to a far-flung area at GGPS Tig (U.C. Sui Shareef Wasti Jeewan Shah) through impugned Notification dated 15.08.2024. Counsel states that such a transfer order was challenged before a Divisional Bench of this Court at Circuit Court, Mirpurkhas in C.P.No.D-1135 of 2024, wherein order dated 09.09.2024 was passed that petitioners therein shall not be removed from current position and Secretary, Education was directed to reconsider the decision of the transfer on account of hardship being faced by the said petitioners and two weeks' time was granted to the Secretary to decide the matter.

Counsel states that petitioner is resident of U.C Syedpur having domicile of that U.C and it was condition precedent for the appointment that the candidate should be from same U.C giving emphasis to the individuals hailing from the same U.C so that they could be readily available in the said U.C. However, counsel submits that he would be satisfied if this petition is disposed of in the light of order dated
