Counsel for respondents-NHA files separate statements on behalf of Director (Design), NHA, Islamabad, Deputy Director (Maintenance), NHA and progress report on behalf of NHA, taken on record. He states that subject Weighing Station, as per the standards available as Annex-C of the statement filed today by Director (Design), NHA, will be constructed, for which contracts are being awarded. Let final construction, as per subject design and drawing, be achieved in a speedy manner and final reports to be furnished to this Court so that appropriate orders could be passed to let the said Weighing Station put to use.

S.P, National Highways & Motorway Police, Jamshoro is present and states that for smooth traffic flow, at least six weighing plates are required at the subject Weighing Station, as one plate used therein sometimes resulted in 15 K.M queue and they have already made correspondence to the NHA authority in this regard so that smooth flow of traffic is maintained, but to no avail. The Deputy Director (Maintenance), NHA, Moro is present and once again he has failed to satisfactorily respond to the queries posed to him as to why Moro sector of N-5 is utterly devastated. In the circumstances, NHA authority is directed to put him under suspension after issuing him appropriate show-cause notice and post some vigilant and responsible officer at his place to speedily complete all the construction and rehabilitation work on the said sector.

Also as per Annexure-D of the report filed by respondent No.5, let all Toll Stations within the province be constructed or remodeled as per the subject Standard Design Specification and all facilities be provided therein. Let the rehabilitation/remodeling work be completed within six months here from.

Adjourned to **17.12.2024.** Interim order passed earlier to continue till the next date of hearing. Let a copy of this order be sent to Chairman, NHA, Islamabad as well as office of DAG for compliance.
