6. Mst. Heer is an aged woman. Applicant is her son, therefore, she is allowed to go with her son Abdul Ghaffar alongwith children, namely, Abdul Jabbar and Muhammad Hanif. She has expressed danger to her life at the hands of her ex-husband Taj Muhammad Chandio. SHO PS Fareedabad present in Court and S.S.P, Dadu are directed to provide full protection to the applicant and his mother Mst. Heer. In these circumstances, an application under Section 491, Cr.P.C is accordingly disposed of.

7. S.S.P, Dadu shall submit the report through Additional Registrar of this Court after every three months for one year regarding the steps taken by him for providing protection to the applicant and Mst. Heer. Mst. Heer would be at liberty to approach the competent Court of law for high handedness committed with her by the private respondents.
