4. Applicant Shah Muhammad alias Shahan Soomro seeks protective bail in Crime No.64/1999 of P.S Sijawal, registered for offences punishable under Sections 302, 324, 148, 149 P.P.C, and 11/16 Z.H.O.

Learned counsel for the applicant contends that name of the applicant is not mentioned in the F.I.R and has been added on further statement of the complainant and has been shown absconder in the challan. It is further stated that applicant was all along available in his house but not aware of his implication in the case, now he has come to know that warrants of his arrest have been issued by the trial Court and he intends to appear before the trial Court but apprehends his arrest, therefore, he prays for protection.

Without touching merits and de-merits of the case, the applicant is granted protective bail for a period of seven days commencing from today on his furnishing solvent surety in the sum of Rs.50,000/- (fifty thousand rupees), and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. This order shall cease to have effect on expiry of aforesaid period of seven days. Meantime, operation of NBWs: issued against the



applicant shall remain suspended for aforementioned period of seven days.

Application stands disposed of.
