

Yasin alias Ghulam Yasin Bukejo and 5. Raheem alias Rahim Bux Bukejo, who ~~was~~ <sup>were</sup> admitted to interim pre-arrest bail by this Court vide order dated 19.10.2015 in Crime No.24/2015 of Police Station Jahan Wah, District Shikarpur, under Sections 395, 506/2, PPC, subject to furnishing solvent surety in the sum of Rs.50,000/- each.

Learned Counsel for the applicant/surety submits that after grant of interim pre-arrest bail, the F.I.R bearing Crime No.24/2015 of PS Jahan Wah has been disposed of under false "B" class, therefore, this criminal bail application was dismissed as not pressed vide order dated 02.12.2016. The Accountant of this Court has also furnished his report endorsing the facts mentioned in the application.

The learned DPG records his no objection to grant of the application.

Since the F.I.R bearing Crime No.24/2015 has been disposed of under "B" class, the surety is no more required. Accordingly, the listed application is allowed. Let the surety documents be returned to the applicant/surety on proper identification, verification and after obtaining a valid receipt.
