Mr. Mohammad Yakoob Dahani, advocate for private respondents.

Through this constitution petition, petitioner has prayed for the following relief (s):-

- a) "direct the Respondent No.1 to 4 not to harass and pressurize the petitioner and his family members/relatives at the instance of respondents No.5 to 9 with a view to force the petitioner to return back the hand of his wife Mst.Marvi daughter of respondent No.5 to the respondents No.5 to 9.
- \* b) Direct the respondent NO.2 SIP abdul Jabbar Kolachi, SHO PS Kot Shahoo, district Shikarpur to produce the petitioner's minor brother Ali Gohar shah, aged about 12 years, before this Hon'ble Court, and this Hon'ble Court may graciously be pleased to set at liberty the detenue Ali Gohar shah from the illegal custody of respondent No.2.
  - c) Direct the respondents No.1 to 4 not to register any false case/F.I.R against the petitioner, his brother Ali Gohar Shah and any of the family members/relatives of the petitioner, showing false abduction of petitioner's wife Mst.Marvi.
  - d) Direct the respondent No.10/SSP Shikarpur, to ensure that the respondents No.1 to 4 shall not harass and pressurize the petitioner and his family members/relatives and the petitioner and his family members/relatives including petitioner's wife Mst.Marvi be provided full legal protection against the respondents No.5 to 9, in accordance with law;
- e) To award costs of the petition.
- f) To grant any other relief deemed fit and appropriate in view of the above-stated facts and circumstances of the case."

Notice of this petition was issued to the respondents as well as A.A.G. DSP Khanpur was directed to provide protection to the petitioners. Today statement of Mst. Marvi is recorded in Court in which she has stated that she has married to one Zaman Shah with her own wishes. She has further stated

that she was not previously married to any one. She is allowed to go with her husband Zaman Shah. Private respondents in their comments have stated that no harassment of whatsoever has been caused to the petitioner nor petitioner shall be harassed in future. Such statements have been placed on record. In view of statements of private respondents which have been placed on record that Mst. Marvi was already married to one Sajid Ali Shah son of Mumtaz Ali Shah, the private respondents would be at liberty to approach the Family Court for seeking remedy available to them under the law.

In view of the above stated circumstances, learned counsel for the petitioners does not press this petition more and it is disposed of accordingly.

DSP Khanpur is present and he is directed to provide every protection to the petitioners in accordance with law.
