Mr. Abdul Hamid Bhurgri, Addl. A. G., and Mr. Ameer Ahmed Narejo, State Counsel, alongwith Yar Muhammad Rind, SDPO, Hyderi, Insp. Faheem Ahmed Farooqui, SHO PS Rehmatpur, P.I Bashir Ahmed Abro on behalf of SSP, Larkana.

Through the instant Constitutional Petition, Petitioner Mst. Balgees Abro has prayed for the following reliefs :-

- That this Hon'ble Court may graciously be pleased to direct a) the respondents No.1 to 6 to produce detainee namely Asad Ali (petitioner's son) before this Hon'ble Court.
- b) That this Hon'ble Court may further be pleased to direct the respondents No.1 to 6 not to cause harassment to the petitioner and further direct them to file their respective affidavits for not causing harassment for the petitioner in future without due course of law.
- That this Hon'ble Court may further be pleased to direct the c) respondents No.1 to 6 to return cash amount of Rs.30000/-, motorcycle and a couloured T.V of Sony Company.
- To direct the respondent No.7 to provide legal protection to the d) life, liberty and the property of the petitioner and save her from the high handedness of respondents No.1 and 6. Further direct him to inquire the matter and take legal action against the respondents No.1 to 6.
- Notices were issued against the respondents as well as 2. learned Addl. A. G. Comments have been filed by respondents No.1 to 7.
- In the comments filed by Senior Superintendent of Police, 3. Larkana, it is mentioned that alleged detenue has not been arrested, but he is absconder in crime Nos.173/2008, 116/2011, 91/2012 of Police Station Darri, Larkana and crime No.191/2014 of Police Station Market, Larkana and according to learned Addl. A.G., he is fugitive from the law.

- 4. In these circumstances, since cases against the alleged detenue have already been challaned before the competent Courts of law and trial Courts where cases are pending shall proceed against the alleged detenue/accused, who has been shown absconder, in accordance with law. Regarding the other reliefs as claimed by the petitioner in the petition, the petitioner may approach the competent Court of law.
  - 5. Petition stands disposed of in the above terms.
