Mr. Altaf-ur-Rehman Bughio, advocate along applicant Syed Kashif Raza

Applicant/accused Syed Kashif Raza son of Syed Mukhtar Ahmed seeks protective bail in F.I.R. No.58/2016, registered at P.S. A.C.E. West Karachi under sections 161, 467, 468, 471, 406, 34 PPC read with section 5(2) of the Prevention of Corruption Act-II, 1947.

It is inter alia contended that protective bail was granted to applicant/accused by this Court in Criminal Bail Application No.561/2018 dated 12.04.2018 in the sum of Rs.50,000/- and P.R. bond in the like amount with direction to the applicant/accused to surrender before the trial court within seven days. It is stated that applicant/accused surrendered before the trial court in the aforesaid crime and he was admitted to interim pre-arrest bail by learned Special Court (Offences in Banks) Sindh at Karachi, vide order dated 18.04.2018, subject to furnishing solvent surety in the sum of Rs.500,000/- with P.R. bond in the like amount. Mr. Bughio appearing for the applicant/accused submits that applicant/accused could not appear before the trial court on 02.05.2018 due to illness and applicant/accused could not furnish surety and was making arrangement for such surety and trial court has recalled the interim pre-arrest bail already granted to him and NBWs have been issued against him by the trial court. It is inter alia contended that applicant/accused is prepared to surrender before the trial court but apprehends his arrest with ulterior motive at the hands of the ACE police on the way to the trial court as NBWs have been issued against him. Serious mala fide on the part of ACE police have been alleged.

Without touching the merits of the case, protective bail for a period of **four** (4) days from today is granted to applicant/accused Syed Kashif Raza son of Syed Mukhtar Ahmed, subject to his furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand) and P.R. bond in the like amount to the satisfaction of the Nazir of this Court. Operation of NWBs issued against the applicant/accused is suspended for 04 days. Applicant/accused is directed to surrender before the trial Court in the aforesaid crime. This order shall cease to have its effect after expiry of 4 days from today or whenever the applicant/accused surrenders before the trial

court, which one occurs earlier. It is made clear that in case applicant/accused failed to surrender before the trial court within the aforesaid period his bail bond shall stand forfeited.

Application is accordingly disposed of.
