Zafar Ahmed Rajput, J.- Through instant bail application, the applicant accused Muhammad Nawaz s/o Arz Muhammad by caste Sohu has sought for pre-arrest bail in Crime No.29/2018, registered U/S 221,223,224,225 and 225-A Cr.P.C. His earlier bail application for grant of pre-arrest bail bearing No.270/2018 was heard and dismissed by the learned VI-Additional Sessions Judge, Larkana vide order dated 10.03.2017. The applicant was admitted to ad-interim pre-arrest bail by this Court vide order dated 14.03.2018. Today matter is fixed for confirmation of the said order.

- 2. At the very outset, learned Additional Prosecutor General considering the fact that co-accused Ghulam Ali who has been assigned the same role in the F.I.R, has been admitted on pre-arrest bail vide order dated 12.06.2018 by the court of learned III-Additional Sessions Judge, Larkana while passing the order in Cr. Bail. Appln. No.756/2018, does not oppose the confirmation of pre-arrest bail to the applicant/accused.
- 3. It appears that all the Sections applied in the F.I.R are bailable except Section 225-A P.P.C, which although is non bailable but does not come within the prohibitory clause of Section 497-A Cr.P.C and all the accused persons nominated in the F.I.R including one Ghulam Ali, who has been assigned

similar role as that of present applicant, have already been admitted to prearrest bail; hence the interim bail granted to the applicant/accused Muhammad Nawaz by this Court vide order dated 14.03.2018 is hereby confirmed on the same terms and conditions.

4. Needless to mention here that in case the applicant mis-uses the concession of bail in any manner, the trial court shall be at liberty to cancel the bail of the applicant after giving him notice.

Bail application stands disposed of in the above terms.
