1. Urgent application is granted.

2. Exemption application is granted subject to all just exceptions.

3. Applicants / accused seek protective bail in Crime No.07 of 2014 for the offence under Section 324/353/148/149 PPC and 6/7 ATA, registered at P.S. Radhan Station. Learned counsel submits that the case against the applicants/accused is false and has been registered due to enmity. Per learned counsel, the applicants/accused intend to surrender before the trial Court but the local police is after them to arrest them as the NBWs have been issued against them by the trial court, therefore, they seek protection.

Without touching the merits and de-merits of the case, the applicants/accused named above are granted protective bail for a period of eight (08) days from today which will expire on 01.05.2017 till 1:00 p.m. against the solvent surety in the sum of Rs.50,000/- (Rupees Fifty Thousand only) each and P.R. bond in the like amount to the satisfaction of the Nazir of this Court just to enable them to approach the competent Court and seek remedy in accordance with law. It is made clear that in case, the applicants/accused fail to make appearance before the trial Court within the time prescribed, the surety submitted before this Court shall stand forfeited.

The bail application stands disposed of in the above terms.
