- 3]. Through this instant Crl. Bail Apln, the Applicants/Accused namely Mohsin Ali Laghari and Faheem Haider have approached this court for seeking protective bail in Crime No.52 of 2021, registered u/s 302/147/148/149/109 PPC at PS Hatri.

Learned counsel submits that since the alleged offence as disclosed in the FIR, the area is surrounded by the complainant, therefore, they are seeking protective bail to enable them to appear before the concerned trial court to avail their remedy.

Be that as it may and without dilating upon merits/de-merits of the case, the applicants/accused are granted protective bail subject to furnishing solvent surety in the sum of Rs.100,000/- [Rupees One Hundred Thousand only] each and PR bond in the like amount to the satisfaction of Nazir of this Court.

The operation of this order shall cease to have effect on the 15<sup>th</sup> day of passing of this order or on any earlier date when the applicants/accused surrender themselves before the concerned trial court.

The Bail Application stands disposed of accordingly.
