Although the request is not impressive at all however taking a lenient view and without considering merits of the case, applicant is granted three days protective bail subject to furnishing surety in the sum of Rs.50,000/- in each case with P.R. bond in the like amount to the satisfaction of Nazir of this Court. This protective bail shall cease to have effect after three days from today or when the applicant surrenders before the concerned Court, whichever is earlier.

Both the bail applications stand disposed of.
