

4. Through instant criminal bail application, the applicant Shoukat Ali son of Gul Mohammad Brohi seeks protective bail in Crime No.55/2014, registered at Police Station Ghouspur, District Kashmore at Kandhkot, under Sections 365-A, PPC and 6/7 of Anti-Terrorism Act.


The learned Counsel submits that initially the applicant/accused was not nominated in the aforementioned F.I.R but later-on he was implicated in the case on the basis of statements of witnesses recorded under Section 161, Cr.P.C. Learned Counsel further submits that the applicant by profession is a driver, is innocent and has been falsely implicated in this case, <sup>- too much so -</sup> he is residing permanently in Village Bungalow Saeedan but even then police did not make any attempt for his arrest and malafidely shown him absconder in the challan with red ink. The learned Counsel further submits that the applicant is ready to surrender before the trial Court with an application for grant of pre-arrest bail but he apprehends his immediate arrest as NBW has been issued against him, therefore, he seeks indulgence of this Court.




Without touching merit and demerit of the case, the applicant is admitted to protective bail for seven (7) days from today subject to his furnishing solvent surety in the sum of Rs.50,000/- (Rupees Fifty Thousand only) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. Meanwhile, operation of N.B.Ws issued by the trial Court against the applicant shall remain suspended for seven (7) days.

This order shall cease to have effect on 04.10.2016 after Court hours or when the applicant surrenders before the trial Court, whichever occurs earlier.

This bail application stands disposed of.
