4. Through instant criminal bail application, the applicants, namely, 1. Dr. Abdul Razzak son of Ali Gohar Mangrio, 2. Abdul Latif son of Din Muhammad Shaikh, and 3. Ali Hassan alias Papan son of Habibullah Khokhar, seek protective bail in Crime No.27/2017, registered at Police Station FIA Anti-Corruption Circle, Karachi, under Sections 23 & 27, read with Section 30 of Drug Act, 1976.

The learned Counsel for the applicants states that the applicants are innocent and have falsely been implicated in this case; that during course of investigation of aforementioned crime the I.O had already taken into possession the relevant record of Store of CMC Hospital Larkana; that Inspection Committee has been constituted by Health Department, Government of Sindh for inspection of receiving and supplying drugs consisting upon 1.District Health Officer, Larkana as its Chairman, 2.M.S CMCH Larkana, 3.AMS (Store) CMCH Larkana, 4.RMO (Store)/Store Officer, CMCH Larkana, and 5.Representative nominated by Deputy Commissioner, Larkana as its members, who all inspected and verified such transaction of delivery and payment. Even then the I.O of aforementioned crime visited the aforementioned Store of CMC Hospital Larkana and secured the relevant record but even then he issued notice dated




29.11.2017 to M.S CMCH Larkana seeking requisite record for the purpose of inspection and for the appearance of applicants before him. Learned counsel states that the applicants have although not been named in the FIR but they apprehends their arrest at the hands of I.O when they will appear for the purpose of investigation therefore, applicants seek protective bail so that they may surrender themselves before the Court concerned alongwith an application U/S 498 Cr.P.C.

Without touching merits and demerits of the case, applicants are admitted to protective bail for seven days w.e.f 12.12.2017 to 18.12.2017 (Both days inclusive) subject to furnishing solvent surety in the sum of Rs.25,000/= each to enable them to appear before the Court concerned alongwith application U/S 498 Cr.P.C. This order shall, however, cease to have effect on 18.12.2017 after Court hours or on the date when the applicants appear before the Court concerned, whichever is earlier.

Application stands disposed of.
