Mr. Naushad Ali Tagar, advocate for the applicants, along with the applicants.

1. Granted.
2. Overruled.
3. Granted subject to all just exceptions.
4. Through instant criminal bail application, applicants/accused 1) Ali Dino alias Sanwal Khan son of Dado Allah Bux, and 2) Mukhtiar son of Mohammad Bachal, both by caste Unar, seek protective bail in Crime No.01/2020, registered at Police Station Allahabad, Larkana, under Sections 386, 506/2, 448, 337-A(i), 114, 148, 149, PPC, read with Sections 6/7-K of Anti-Terrorism Act, 1997.

Learned Counsel states that the applicants are innocent and have falsely been implicated in this case; that although the names of applicants appear in the FIR, but in the investigation conducted by JIT they were exonerated and case against them was recommended for disposal under "C" class, but the learned trial Court ignoring the investigation took the cognizance against the applicants/accused; that the applicants/accused are ready to surrender before the concerned trial Court along with an application under Section 498-A, Cr.P.C to prove their innocence, but as the NBWs have already been ordered to be issued against them in Special Case No.02/2020, they apprehend their



imminent arrest at the hands of police, hence they seek protection of law.

Without touching merits and demerits of the case, protective bail for a period of seven days with effect from 10.02.2020 to 16.02.2020 (both days inclusive) is granted to the applicants subject to their furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand only) each and P.R bonds in the like amount to the satisfaction of Additional Registrar of this Court, enabling them to surrender before the Court concerned. This order shall, however, cease to have effect on 16.02.2020 after Court hours of any earlier date when the applicants surrender themselves before the concerned Court.

The bail application is disposed of.
