1. Urgency application granted.
2. Over-ruled.
3. Exemption allowed subject to all just exceptions.
4. Through instant criminal bail application, applicant **Goro alias Ali Gohar Sanjrani son of Shahzado** seeks protective bail in Crime No.23 of 1998, registered at P.S Gerello (*District Larkana*), under Sections 460, 458, 148 and 149 P.P.C.

Learned counsel for applicant states that applicant is innocent and has falsely been implicated in this case; that all the five other co-accused have been *acquitted* of the charge by learned 1st Additional Sessions Judge/ Special Judge (*STA*) Larkana vide judgment dated **31.7.2002** passed in Special Case No.59/2000, while case of the applicant/ accused being *proclaimed offender* was kept on *dormant file*; that the applicant was very much available at his given address but the concerned police never made any contact with him for recording his statement and for his arrest; that applicant is ready to surrender before the trial Court to prove his *innocence* alongwith an application under Section 498 *Cr.P.C.*, but as the life NBWs have been issued against him, he apprehends his immediate arrest by the hands of police, hence he seeks *protection* of law.



Without touching *merits* and *demerits* of the case, applicant is admitted to *protective bail* for seven (07) days *w.e.f.* 04.02.2020 to 10.02.2020 (*both days inclusive*) to enable him to surrender himself before the Court concerned subject to furnishing solvent surety in the sum of **Rs.50,000/-** (*Fifty thousand rupees*) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court. This order shall however cease to have effect on 10.02.2020 or on any date when the applicant *surrenders* before the Court concerned, *whichever* is earlier. In the meantime, operation of **N.B.Ws**, if any, issued against applicant shall remain *suspended*. The application stands disposed of.
