

Through instant criminal bail application, applicants/accused, namely, 1) Mumtaz Ali, 2) Waqar Ahmed, both sons of Haji Mohammad Ibrahim @ Baggan, 3) Mohammad Ramzan son of Sadaruddin @ Sadoro, 4) Mohammad Islam son of Mohammad Ismail, 5) Sikander Ali son of Wahid Bux, 6) Moharram Ali, 7) Yaseen Ali, all three sons of Wahid Bux Soomro, 8) Mohammad Khan @ Khan Mohammad son of Ali Khan @ Ali Mohammad, 9) Allamuddin son of Daim Soomro, 10) Mohammad Murad son of Mohammad Suleman, 11) Mst. Zaibul Khatoon wife of Mohammad Ibrahim, 12) Mst. Hasina wife of Ali Mohammad @ Ali Khan, 13) Mst. Zarina wife of Mumtaz Ali, 14) Mst. Seenghar Khatoon wife of Sikander Ali Soomro, seek protective bail in Crime No.49/2021, registered at Police Station B-Section, Thul, for offence under Sections 302, 324, 353, 427, 148, 149, 224, 225, PPC read with section 6/7 of Anti-Terrorism Act, 1997.

At the very outset, learned Counsel submits that the applicants are innocents and have falsely been implicated in this case; that there are general allegations against the applicants and none of the applicants has been assigned specific role of causing any injury to the deceased or any of the injured persons; that the applicants are ready to surrender before the Court concerned along with an application for pre-arrest bail, but as they apprehend their immediate arrest, therefore, they seek indulgence of this Court.



Without touching the merits and demerits of the case, the applicants/accused are admitted to protective bail for ten (10) days with effect from 29.07.2021 upto 07.08.2021 (both days inclusive) subject to their furnishing solvent surety in the sum of Rs.25,000/- (Rupees twenty-five thousand) each and P.R bonds in the like amount to the satisfaction of Additional Registrar of this Court to enable them to appear before the Court concerned along with an application under Section 498, Cr.P.C. This order shall, however, cease to have its effect on 07.08.2021, after Court's hours or on any date when the applicants surrender themselves before the Court concerned, whichever occurs earlier.

This bail application stands disposed of.
