

Since common questions of law and facts are involved in all the listed petitions, the same are disposed of with this single Order.

Through instant petitions, petitioners seek their appointments on deceased quota as their fathers, who were working in Education Department, Govt. of Sindh, died during their service.


Learned Addl.A.G submits that vide Notification bearing No.SO(C-IV)SGA&CD/4-17/16, dated 13<sup>th</sup> July, 2016, issued by the Govt. of Sindh, Services, General Administration & Coordination Department, a Committee has been constituted to scrutinize and decide the cases of appointments against deceased quota from BS-01 to BS-07 as per law/rules/policy with the composition of 1. Chief Secretary, Sindh (Chairman), 2. Secretary, Law Department (Member), and 3. Secretary, concerned department (Member). He further submits that the said notification was subsequently modified by the Govt. of Sindh, Services, General Administration & Coordination Department, vide Notification No.SO(C-IV) SGA&CD/4-17/16, dated 16<sup>th</sup> August, 2016, for the posts from BPS-01 to BPS-11 instead of posts from BPS-01 to BPS-07, as per law/rules and recruitment policy. Learned Addl.A.G undertakes that the cases of the petitioners for their appointments against deceased quota shall be considered by the Committee constituted vide Notification bearing No.SO(C-IV)SGA&CD/4-17/16, dated 13<sup>th</sup> July, 2016, issued by the Govt. of Sindh, Services, General Administration & Coordination Department, as per law/rules/recruitment policy, within a period of two (3) months provided that the petitioners file applications for their appointment on deceased quota by addressing to Chief Secretary, Govt. of Sindh.



In view of statement of learned Additional Advocate General, Counsel for the petitioners submit that these petitions may be disposed of directing the alleged Committee that, if the petitioners file applications for their appointment against deceased quota, the same shall be considered by them within a period of three months from the date of application. Order accordingly. All the listed petitions stand disposed of.
