The petitioner, through instant petition seeks following relief:-

- a) To direct the respondent No.1 to 6 to probe into the matter and to register the FIR against respondent No.7 to 14 on account of grabbing Govt. lands by virtue of corruption.
- b) To direct the respondents No.2,3 & 6 to cancel the bogus entries No.197 and 36 of revenue record regarding Survey No.62/2 (2-20), 68 (3-8), 156 (1-02), 358 (5-6), 487 (2-4), 519 (0-12), Total area (14-12) acres, in Deh Sonahri Raitee, Tapa Karira, old Taluka Dokri and now Taluka Bakrani District Larkana which may be declared as illegal, null and void.

The respondent No.4 has filed his comments where, in para No.6 he has stated as under:-

"It is prayed that petitioner Bashir Ahmed Jamali submitted application to Deputy Director ACE Larkana, allegations are that S.No.62/2, 68, 156, 358, 487 and 519 area 14-12 acres Deh Sonahari Raitee Tapa Karira Taluka Dokri now Tapa Bakrani and other survey numbers is Central Government Land. In the year 1998 Tapedar Ali Gohar Sohu in collusion with private person Hoondal Khan Noohani & others kept entry of above Central Government Land bearing No.640 and 274 illegally by way of fraud and forgery and sold out the same to different persons. In the year 1996 Assistant Commissioner Larkana cancelled the above bogus entries and returned back the land in Central Government Pool. Such case FIR No.33/98 was registered at P.S ACE Larkana against Tapedar Ali Gohar Sohu and others and the accused persons were challaned in the Honourable Court of Special Judge Anti-Corruption Larkana. Thereafter in the year 2012-13 alleged Hidayatullah Memon Assistant Commissioner Bakrani, Abdul Haque Chawro, Mukhtiarkar Bakrani and Tapedar Imdad Ali Mashori in collusion with private persons namely Muhammad Hassan Junejo, Zulifqar Ali Abro, Mazhar Ali Abro and Iltaf Hussain Abro again issued

sale fard certificate in favour of Ali Gul Abro of the above said Central Government Land and sold out to Muhammad Hassan Junejo, such entry in his favour vide bearing No.36 dated 19.4.2013 was kept by alleged persons and caused loss to the Government.

During course of verification the statement of petitioner Bashir Ahmed Jamali was recorded, who fully supported the allegations. After recording statement of petitioner Ex-Circle Officer ACE Larkana submitted verification report to the Deputy Director ACE Larkana vide No.1445 dated 01.6.2015 with recommended for placing the matter before ACC-I Sindh Karachi, seeking permission for open enquiry against Hidayatullah Memon Ex-Assistant Commissioner (BPS-17) and others.

It is prayed that, after receiving permission from Committee ACC-I Sindh Karachi the enquiry will be conducted as per ACE rule, for ascertain the allegations of petitioner.

Apparently, the grievance of the petitioner has been redressed, the petition is therefore disposed of directing the respondent No.4 to complete the enquiry as per ACE Rules within shortage possible time and submit copy of report to this Court through Additional Registrar.
