## ORDER

ADNAN-UL-KARIM MEMON – J:- The Petitioner's case is that the ancient and historically significant tombs of Sufi Hayat Faqeer and Chuttal Faqeer Khoso, dating back two centuries, are located in Taluka Shahdadkot, District Kamber-Shahdadkot, near village Sanjar Bhatti. This site, also known as Mukaam Khosan Jo, has been officially recognized as possessing historical and architectural value, and designated as a protected antiquity. Despite repeated appeals to the relevant authorities for the construction of a boundary wall to safeguard this graveyard, no action has been taken. Therefore, the Petitioner requests that this Court direct the Respondents to construct a complete boundary wall around the graveyard at government expense.

- 2. We have heard from the petitioner who is present in person and perused the record with his assistance. Learned A.A.G has referred the para-wise comments filed on behalf of respondent No.2 and argued that the Deputy Commissioner, Kamber-Shahdadkot has already forwarded the request of the petitioner to the Secretary, Archeology, as well as a Secretary Zakat, Government of Sindh, vide letter no.04.01.2024 for the aforesaid purpose, as such this petition can be disposed of in terms of the recommendation of the Deputy Commissioner.
- 3. This petition can be efficiently resolved by directing the Commissioner/
  Deputy Commissioner of Larkana to oversee the construction of a boundary wall
  around the subject graveyard. The Municipal Authorities shall coordinate with the
  Commissioner/Deputy Commissioner by ensuring that the construction of the
  boundary wall is done within a reasonable time at the public expense. The
  Commissioner should secure the necessary funding from the Government of Sindh for
  this purpose, thereby protecting this designated historical site from encroachment.
  This undertaking should be completed within two months positively.
- 4. The petition stands disposed of in the above terms. Let a copy of this order be transmitted to the respondents for compliance.
