The instant petition has been filed with the following prayers:

- (a) *This Hon'ble Court be pleased to direct the respondents No.1 to 4 to cancel the fraudulent, bogus and illegal entry No.29 made in the revenue record / Dakhal Kharij Register of Deh Thano Wadho, Taluka Warah, District Kamber-Shahdadkot, in respect of 0-34 paisa share purchased by petitioner's father Tharo Khan Lashari from Survey No.226 of Deh of Thano, Taluka Warah, District Kamber-Shahdadkot, in the name of respondents No.5 and 6, being illegal, manipulated, fabricated and based on fraud;*
- (b) *To direct the respondents No.7 & 8 not to harass the petitioner and his family at the instance and behest of respondents No.5 and 6, with further direction to respondent No.9/SSP, Kamber-Shahdadkot to provide legal protection to the petitioner and his family against the respondents No.5 to 8 and subordinates of respondents No.7 and 8;*

The learned Counsel for the petitioner submits that for the redressal of his grievances, the petitioner had approached the concerned quarters, on that the Additional Commissioner, Revenue, Larkana Division, issued a letter dated 27.5.2014 to Assistant Commissioner, Taluka Warah (Annexure-F, page 21 of the petition), but till date no proceeding has been conducted by the Assistant Commissioner, Taluka Warah, the respondent No.2.

The Counsel for the private respondents submits that the Assistant Commissioner, Taluka Warah had issued number of notices to the petitioner but since he is not making his presence before him, the matter is not being proceeded by the respondent No.2.

The Counsel for the petitioner denying the contention of Counsel for private respondent submits that till date no proceeding has been initiated by the respondent No.2, hence this petition may be disposed of directing to respondent no.2 to proceed in accordance with law on the directions of the Additional Commissioner, Revenue, Larkana Division vide letter dated 27.5.2014.

We, therefore, dispose of this petition directing the Assistant Commissioner, Taluka Warah, the respondent No.2, to look into the matter and after hearing all the parties concerned pass appropriate order in accordance with law within two months hereof on the letter issued by the Additional Commissioner, Revenue, Larkana Division.
