Accordingly, it is ordered that any further between father and wards i.e. petitioners No.2 to 4 and respondent No.1 meeting shall be subject to payment of such charges in advance so that it may be convenient for her (petitioner) to bring the children for meeting.

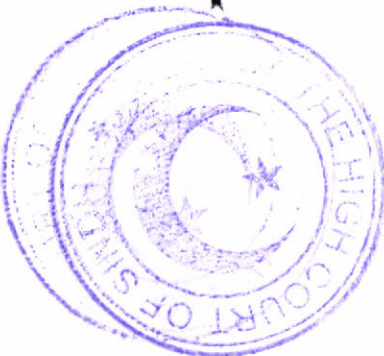
