The petitioner's immediate concern is for release of the consignment till the decision of appeal pending before the Collector of Customs (Appeals) Karachi.

Mr. Ghulam Rasool Korai, advocate undertakes to file Vakalatnama and comments on behalf of the respondent No.2.

Since there is no issue of importability, let the goods be released on securing the differential amount of duty and taxes with the Nazir of this court, who shall invest the same in best government profit bearing scheme. On deposit of such amount a certificate be issued for the immediate release of the consignment. The fate of amount shall be decided subject to outcome of the decision by the Collector of Customs (Appeals) Karachi.
