In terms of the earlier order dated 30.06.2014, the detainee Mst. Seema has been

produced by respondent No.3. The detainee has been categorically asked as to whether she

was illegally or improperly confined by private respondents, which she has denied. She has

further asserted that she wants to live with the applicant being his legally wedded wife. She

also further states that she had contracted marriage with applicant on her own free will

which had made mischief to her relatives, on account of which they were not allowing her

to lead her life with the applicant.

Be that as it may, since the detainee has categorically stated in Court that she has

contracted marriage with applicant on her free will and accord and wants to live with him. I

see no impediment to refuse her to lead her life with the applicant. Consequently, the

detainee is allowed to lead her life with the applicant, as per her desire.

The Criminal Miscellaneous Applications stands disposed of in the above terms.
