4. Through this Crl. Bail Application, applicant, namely, Imam uddin son of Ghulam Qadir Chandio, seeks protective bail in Crime No.38 of 2017 registered at Police Station Civil Line, District Larkana, under sections 371-A, B, 376, 420, 34 PPC, enabling him to surrender before the concerned trial Court.

Learned counsel for the applicant submits that though the FIR in this matter was registered in 2017; however, the applicant had no knowledge of his implication in the said case and now it has come in his knowledge that he was nominated, whereas, NBWs have been issued against him. He further submits that other co-accused have been acquitted of the charge by the trial Court. He prays for grant of protective bail enabling the applicant to surrender before the trial Court.

Be that as it may, without touching the merits and demerits of the case, applicant Imam uddin son of Ghulam Qadir Chandio is admitted to protective bail for (07) seven days from today subject to his furnishing solvent surety in the sum of Rs.30,000/- (Rupees. Thirty thousand only) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court to enable him to approach the Court concerned. This order shall cease to have effect on 15.09.2020 or on the day when the applicant makes his appearance before the Court concerned, whichever is earlier. The operation of

NBW's, if any, issued against the applicant shall remain suspended for the period of effectiveness of this order.

Bail Application stands disposed of.
