By this common order above captioned Crl. Transfer Applications are disposed of as they all are offshoot of main FIR bearing Crime No.109/2014.

Learned counsel for the applicants/accused seeks transfer of Sessions Cases Nos.1098/2014, 1100/2014, 1099/2014, 1097/2014, 1095/2014 & 1096/2014 arisen out of F.I.Rs No.113, 116, 115, 112, 110 and 111 of 2014, respectively, registered at Police Station Lakhi Gate, Shikarpur under section 23-I(a) Sindh Arms Act 2013, solely on the ground that the main case arisen out of FIR No.109/2014 under section 395, 324, 353, 147, 148, 427, 120-B, PPC registered at Police Station Lakhi Gate Shikarpur is pending adjudication before the Court of Vth Additional Sessions Judge, Shikarpur, therefore, aforementioned cases may also be transferred from the Court of learned IIIrd Additional Sessions Judge Shikarpur to Vth Additional Sessions Judge, Shikarpur.

Learned D.P.G submits that since Sessions Cases mentioned above are offshoot of the main case arisen out of Crime No.109/2014, he has no objection to the transfer of the cases from the learned IIIrd Additional Sessions Judge, Shikarpur to Vth Additional Sessions Judge, Shikarpur.

The abovementioned FIR Nos.113, 116, 115, 112, 110 & 111 2014 are offshoot of FIR No.109/2014, therefore, in order to avoid any conflict in judgments, aforementioned cases are withdrawn from the file of IIIrd Additional Sessions Judge,



Shikarpur and transferred to the Court of Vth Additional Sessions Judge, Shikarpur where the main case arisen out of FIR No.109/2014 is pending adjudication, for disposal in accordance with law.
