Mr. Safdar Ali Ghouri, advocate for the petitioner along with petitioner.

Petitioner claims to be Regional Manager (BPS-16) working in Utility Stores Corporation and posted at Shikarpur Region has been transferred vide impugned order dated 23.02.2018 from Shikarpur Region to Laralai Region, which according to him, is against 'Wedlock Policy' of Government of Pakistan which facilitates posting of husband and wife in the service at the same station. To establish it while referring to the documents available in the file learned counsel has contended that wife of the petitioner namely, Mst. Khalida Parveen is working as a Primary School Teacher and is currently posted at Govt. Girls Primary School Lashari, Naudero, besides he has school-going children. He has further contended that the petitioner has already filed a representation against his transfer which is pending before respondent No.2 Managing Director, Head Office Jinnah Avenue, Blue Area Islamabad. He has next contended that the learned Lahore High Court in Writ Petition No. 6891 of 2014 and Writ Petition No.8161 of 2014 while dealing with the identical situation regarding employee of Utility Stores Corporation of Pakistan was pleased to suspend the transfer order for two weeks and meanwhile directed the respondent No2 to decide the representation of the petitioner. Learned counsel submits that the petitioner would be satisfied if the same treatment is

meted out to him i.e. the impugned order suspended for two weeks with direction to respondent No.2 to decide his representation, if pending with him, on its own merits.

Mr. Nisar Ahmed G. Abro, learned D.A.G present in Court in some other matters waives notice of this petition and has no objection to the above proposal.

In view of above submissions coupled with the orders passed by the learned Lahore High Court in the identical matters available at page No.85 and 93, this petition is disposed of along with listed applications, however, with direction to the respondent No.2, Managing Director, Head Office, Jinnah Avenue, Blue Area Islamabad, to decide the representation of the petitioner against the impugned order, if it has been filed, within a period of two weeks from today and for that period i.e. two weeks from today the impugned order dated 23.02.2018 transferring the petitioner from Shikarpur Region to Loralai Region shall remain suspended.
