This application was filed on 20.09.2021 challenging the order dated 05.08.2021 passed by Additional Sessions Judge-II Tando Muhammad Khan, whereby application of applicant for registration of FIR has been dismissed, but since then the applicant has not taken any interest to pursue this application even today he is called absent. Accordingly, this criminal miscellaneous application is dismissed in non-prosecution along with listed applications.
