At the out set learned Addl. A. G contends that his Court has passed order dated 8<sup>th</sup> September 2015 at Sukkur Bench, whereby all the petitions pertaining to "Delimitation" have been transferred to Karachi for placing before the Hon'ble Chief Justice on the plea that in order to avoid the chance of conflicting judgment they may be decided by one and same Bench. We have perused such order and learned counsel for the parties are agreed on this proposition and request for the same.

Accordingly, all the petitions are sent to Principal seat at Karachi for placing before Honourable Chief Justice for appropriate orders.
