The case of petitioner is that Government of Pakistan and Government of China entered in the agreement for rebuilt of economy of Pakistan and given the name as China-Pakistan Economic Corridor (CPEC) which is a collection of infrastructure projects that are under construction throughout Pakistan beginning in 2013 at that time the original value was \$47 billion, the value of CPEC projects is worth \$62 billion as of 2020. As per short term Project the Sukkur to Hyderabad Motorway was to be constructed and the cost of project prepared in the year 2016-2017. At the relevant time the cost of un-approved project was shown Rs.163000.000 and the record reflects that Sukkur-Hyderabad motorway showing land acquisition approved in the year 2014. In the year 2018 National Highway Authority Pakistan (NHA) invited proposal regarding the design, Traffic studies, Commercial Feasibility Study and Bid Evaluation/Bid Comparative Analysis for Hyderabad-Sukkur Motorway project on Built-Operate-Transfer (BOT) Basis under Public Private Partnership (PPP) Arrangement. Learned counsel /Petitioner also submits that due to non-construction of motorway, the National Highway Authority also not repairing the road leading from Sukkur to Hyderabad which is presently in worst condition and the people/public at large is suffering badly and there is

big cry in the public at large, when NHA is collecting Toll tax from the vehicles.

The respondents have not started the construction of Motorway Sukkur to Hyderabad M-6 and National Highway Authority invited another Bid in the year 2020 but no fruitful result has neither come on record nor the respondents started any development for construction of Sukkur-Hyderabad Motorway.

After institution of the matter, the notices were issued to the respondents as well as DAG. On last date of hearing viz. 08.03.2022 Project Director M-6 appeared who filed certain documents and he has assured that required work will be started at the site as soon as possible. However, the Court noted that earlier this project was halted due to unknown reasons and it is again started but as a result whereof the cost of the Project has enormously increased.

Today Akhlauqe Nabi Dayo Project Director M-6 and Muhammad Arshad Deputy Director (Legal) are present and state that now the total cost of the project is 308,194 Millions. It is surprising to note here that in between 2016-17 and year 2022 the difference of the cost is 145194 Million and in such circumstances the loss has occurred in the project near about 145194. The statement filed today by respondent No.7 is not satisfactory because no reason has been shown in the statement that why the project has been delayed.

In the circumstances, let notice be issued to Respondent No.2 (Secretary of Communication) Government of Pakistan Islamabad and Respondent No.7 (Chairman National Highway Authority Islamabad) who are directed to appear in person on the next date along with their comprehensive reports. However, notice shall also be issued to Director General NAB Sukkur.
