No.D-7907/2017 [Aijaz Ahmed & Others v. Province of Sindh], which was disposed of by Order dated 12.12.2017. - 2. Today, the Registrar, Cooperative Societies (Respondent No.2), who is present, has submitted a copy of his Order dated 14.5.2025. The said Order, inter alia, appoints an Election Officer and enjoins that elections for the position of President and the entire Managing Committee of Saudagran Cooperative Housing Society Ltd (Respondent No.7) shall be held within thirty (30) days of the Election Officer receiving the Order.
- With regard to the eligibility of individuals to contest the upcoming elections, the Registrar, Cooperative Societies, shall ensure that the elections are conducted strictly in accordance with, inter alia, the Sindh Cooperative Societies Act and Rules, 2020, in particular Rule 9, and the Byelaws of the Society. As a result, this Petition, along with all pending applications, is hereby of <u>disposed of</u>.
