The Supreme Court of Pakistan appears to have determined the controversy vide judgment passed in the case of Collector of Customs Lahore vs. Wasim Radio Traders, Lahore reported as 2023 SCMR 1716. The said judgment was relied upon and followed earlier by Division Bench of this Court in the judgment passed in the case of Shamim Ahmed & another v, Federation of Pakistan and others reported in 2024 PTD 736.

Needless to state that the aforementioned judgments are binding upon this Bench pursuant to Article 189 of the Constitution and multiline principle and could not be distinguished by the petitioners' counsel. Therefore, in mutatis mutandis application of the ratio enunciated, these petitions are dismissed.
