In his statement SHO, has categorically denies to have custody of alleged detenues however, submits that in-laws of the petitioner including her brother in law are wanted in Crime No. 04/2025, offence under section 397 PPC registered at Police Station Muhammadpur Odho, therefore, they have conducted raids, but the Petitioner has maintained instant petition so that they may not perform their duties. He also annexed list of cases. The brother in law of petitioner Moula Bux is also absconder in the captioned crime hence, submits that petition may be disposed of by directing the Petitioner to produce the wanted accused/ her brother in law as well as relatives.

The copies of the statements have been handed over to the Counsel for the petitioner who upon receipt of the same submits that police has replied evasively, two women and a boy aged about 14/15 years are missing since 3.5.2025, and still their whereabouts are not known hence they apprehends danger to their lives.

Since liberty as well as life of the alleged detenues are involved in this case therefore, SSP, Jacobabad is directed to look into the matter personally and verify whether the contention raised by the Petitioner are true or the stance taken by the police. In both cases SSP, Jacobabad shall ensure whereabouts of the alleged detainees and submit his report before this Court on the next date of hearing.

A copy of order be sent to SSP, Jacobabad and DIGP, Larkana for compliance. Additional Registrar shall ensure the compliance.
