This petition was dismissed on account of laches vide order dated 5.8.2024, thereafter, the counsel for the petitioner moved review application however, he sought disposal of review application with direction to the Secretary Local Government to look into the matter, if the cause of the petitioner subsist and in view of the above MA No.1435 of 2024 was disposed of and respondents were directed to look into that aspect of the case and their hands ends without prejudiced the right of the party as a lis had already been disposed of as discussed supra. Today, Dr. Waseem Shamshad Ali Secretary to Local Government has submitted reply and the contents whereof are reproduced as under:-

"Learned Counsel for the petitioner states at bar that this petition was disposed of vide order dated 05.08.2024 based on laches and thereafter he moved review application; however, he seeks disposal of this application with direction to the Secretary Local Government to look into the matter, if the cause of the petitioner still subsists.

In view of above, application bearing M.A No.1435/2024 is disposed of. Let respondents see all aspects of the case at their end without prejudice the right of the party as the lis has already been disposed of on account laches."

- 2. It is further added that the alleged Contemnor i.e. Syed Khalid Hyder Shah has been transferred from the post of Additional Chief Secretary, Local Government & HTP Department on 13.05.2025 (Annexure-I). Furthermore, it is submitted that:-
- a) The Honorable High Court has already dismissed the instant petition based on latches vide order dated 05.08.2024 (Annexure-II).
- b) That Honorable Court has disposed of the review application vide order dated 07.10.2024 to see all aspects of the case without prejudice the right of the party.

c) On scrutiny of the copies of the documents provided by the Petitioner, it revealed that claim of the Petitioner for appointment on 18.01.1996 as Secretary UC Dilyar Taluka Khipro District Sanghar is false as no authentic record of the petitioner is available in Sindh Local Government Board.

That on the basis of boars and fake documents 30 years

That on the basis of bogus and fake documents 30 years back appointment cannot be claimed as a fundamental right by the Petitioner.

- e) In this connection the claim of the Petitioner is not justifiable & untenable as per law, please.
- 3. In view of above stated facts, it is most respectfully prayed to kindly discharge the Contempt Notice against alleged Contemnor as the claim of the Petitioner is not justifiable & untenable as per law."

In view of above report, the contempt application stands disposed of no case for further indulgence is required.
