Statements filed on behalf of official respondents No.1, 2, 3 & 6, taken on record, copies of same have been provided to Mr. Kalhoro counsel for the petitioners. Official respondents have stated in their statements/comments that they had never harassed the petitioners and their family members nor they intend to do so in future. Private respondents No.9, 11 & 13 are present. Learned counsel for the petitioners submits that after issuance of the notice by this Court against the private respondents, the respondents No.9, 11 & 13 had come to the house of the petitioners and threatened them that why they have filed this petition and in case they shall not withdraw the petition, they will be dealt with iron hand. Therefore they may be directed not to harass the petitioners and official respondents may also be directed to provide legal protection. Private respondents No.9, 11 & 13 are present and submit that they have never harassed the petitioners nor intends to do so in future and further they undertake that the petitioners would not be harassed in any manner.

Learned Asstt. A. G Sindh and learned D. P. G submitted that official respondents are legally bound to provide legal protection to all the

citizens including the petitioners without any discrimination. They after going through the record, ensure that official respondents shall conduct themselves strictly in accordance with law and provide legal protection of life, honour and property to the petitioners and their family in the manner that no one shall cause them harassment.

Learned counsel for the petitioners being satisfied with the statements made by learned Asstt. A. G and learned Addl. P. G and undertaking given by the private respondents, sought disposal of instant petition with direction to the official respondents to provide necessary protection to the petitioners in the manner that no one shall cause them harassment.

In view of whatever discussed above, instant petition stands disposed of with directions to official respondents to conduct themselves strictly in accordance with law and provide necessary legal protection of life, liberty, honour and property to the petitioners and their family members in the manner that no one shall cause them harassment.
