Mr. Munawar Ali Abbasi, Asst. A.G., along with SIP Meer Hassan of PS Waleed, Larkana, SIP Ali Dost Chandio on behalf of SSP, Larkana, Insp. Ashique Hussain Chandio on behalf of DIGP, Larkana Range and ASI Hakim Ali Hingoro of PS Kotri, District Jashmoro.

Mr. Abdul Rauf Korai advocate by affecting his presence on behalf of respondents No.5 to 8 submits that neither they harassed the petitioners nor intend to do so in future. He further submits that he will have no objection if the prayer made in instant petition is allowed and the petition is disposed of. Learned AAG, learned Addl. P.G as well as the police officers present in Court also undertake to provide protection to the petitioners in accordance with law.

While raising the Court after tea-break, when matter in hand was taken up, the petitioners came up and complained that one Sabir Ali son of Atta Muhammad Chandio, who is in support of respondents No.5 to 8, has recorded their video in Court room inspite of their resistance. They therefore raised hue and cry, which attracted the security personnel/police officials posted inside and outside the Court room, who rescued them. Now, said Sabir Ali Chandio is in custody of security personnel. He has been called before the Court and in open Court he admitted the guilt he committed; however, offered an apology which the petitioners have refused on the ground that he is the person who intends to demoralize and cause severe harm to them/petitioners at the behest of private respondents No.5 to 8; hence, he may be prosecuted as the video recorded by him is intended to be made viral which would cause insult and damage to their reputation as well as respect and it being an offence he may be convicted. Learned Addl. P.G. and learned AAG present submit that the offence committed by said Sabir Ali Chandio is increasing day by day and the respect as well as honour of innocent and respectable citizens has been put at stake, therefore, he should be prosecuted.

Accordingly, Sabir Ali Chandio is hereby taken into custody and is directed to be handed over to SHO of Police Station Rehmatpur, Larkana with



directions that he be booked under the relevant laws of the land. Additional Registrar of this Court is directed to ensure compliance of the directions.

SIP Meer Hassan of PS Waleed, Larkana, present in Court, undertakes to escort the petitioners for safe journey to their home/destination. Learned AAG as well as learned Addl. P.G. also undertake to follow the directions. Copy of order be provided to learned AAG as well as learned Addl. P.G., for compliance. A copy of order shall also be faxed to SSP, Larkana for compliance.

Instant petition is disposed of in above terms.
